RESOLUTION AUTHORIZING APPLICATION SUBMISSION AND LOCAL MATCH COMMITMENT

RESOLUTION OF HUNTINGTON COUNTY COMMISSIONERS OF HUNTINGTON COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE RECOVERY HOUSING PROGRAM APPLICATION TO THE INDIANA OFFICE OF COMMUNITY AND RURAL AFFAIRS AND ADDRESSING RELATED MATTERS

WHEREAS, the Commissioners of Huntington County, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government for the elimination and prevention of blight; and

WHEREAS, Huntington County, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low- and moderate-income residents;

NOW, THEREFORE, BE IT RESOLVED by the Huntington County Commissioners, Huntington County Indiana that:

- 1. The commissioners are authorized to prepare and submit an application for grant funding to address a Recovery Housing Project, and to execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Indiana Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.
2. The Huntington County Commissioners, Indiana hereby commits the requisite local funds in the amount of xxx Hundred Thousand Dollars (\$xxx,000.00), in the form of \$xxx,000.00 in Place of Grace cash on hand as matching funds for said program, such commitment to be contingent upon receipt of Recovery Housing Program funding from the Indiana Office of Community and Rural Affairs.

Adopted by the Huntington County Commissioners, Indiana this 16th day of October, 2023, at 9:30 AM.

This Resolution shall be in full force and effect from and after its passage and approval by the county Commissioners.
