LANDOWNER CONCERNS:

William Fahl Drain Landowner: Shawn Putt 449 S Broadway Huntington, IN 46750

During the September 5, 2024 Huntington County Drainage Board Meeting, Shawn.Putt's contractor, Jason Doctor, was denied approval to install a septic outlet into the drain due to the drain being bottom dipped and de-brushed in the near future. Shawn came before the board today to discuss options to get his septic installed so he could proceed. After discussion, it was decided Jerry Meehan would contact Alicia Symons at the Huntington County Health Department to approve the Putt's to utilize the existing septic system on the property, and the Drainage Board would approve the outlet of the new system when the bottom dipping was completed. Shawn Putt is also requesting to work in the right-of-way to harvest three trees. Terry Keiffer made a motion to allow, Bob Gressley seconded, motion passed 5-0

Jerry Meehan presented photos of completed rock chutes, armoring, and tree removals at various points on the ditch. He also presented photos of the crossings constructed by Cale Eckert that the banks have not been rip-rapped per the approval of each crossing. After discussion, the consensus of the Board is for Jerry to reach out to Cale to get a timeline of completion.

Jerry Meehan informed the Board that the area under the Third Street bridge is 18" higher than under the Fourth Street bridge. After investigation it was discovered that a mixture of sand and slurry from a 2015 project has settled under the bridge.

As a part of the project to bottom dip and de-brush the drain, landowner, Lee Harvey has contracted with Amor Excavating to rip-rap along the length of his building. Terry Keiffer made a motion to pay \$1,000.00 of this project. Bob Gressley seconded, motion passed 4-0.
