REPORTS FROM COMMITTEES, BOARDS, OR COMMISSIONS: Council Member Funk reported that the Plan Commission met regarding Ordinance 4-C-25 and the Plan Commission gave a unanimous favorable recommendation. No other reports were given by Council members.
