

**Ordinance NO. 2024-07**

**ORDINANCE ESTABLISHING**

**UNIFORM FEE SCHEDULE FOR**

**HUNTINGTON COUNTY DEPARTMENT OF HEALTH**

WHEREAS, the Huntington County Department of Health is under the oversight of the Board of Commissioners of Huntington County, Indiana; and

WHEREAS, Indiana Code 36-1-1-1 to 9, inclusive, grants certain home rule powers to Huntington Department of Health of Huntington County, Indiana, to fix the permit and service fees for the Huntington County Department of Health.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the County of Huntington, State of Indiana, that a Uniform Fee Schedule be established for the Huntington County Department of Health reading as follows:




