2025 SALARY ORDINANCE AMENDMENT

Synopsis: This ordinance, if adopted, would amend Ordinance 14-C-24 so as to clarify and update certain positions and salaries.

AN AMENDMENT TO ORDINANCE 14-C-24 FIXING SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF HUNTINGTON, INDIANA FROM AND AFTER DECEMBER 29, 2024, THROUGH THE PAY PERIOD ENDING DECEMBER 27, 2025; AND HOURLY EMPLOYEES OF THE CITY OF HUNTINGTON, INDIANA, FROM AND AFTER DECEMBER 22, 2024 THROUGH THE PAY PERIOD ENDING DECEMBER 20, 2025.

THEREFORE, BE IT ORDAINED, by the Common Council of the City of Huntington, Indiana in meeting duly assembled that only the listed portions and sections of Ordinance 14-C-24 are hereby amended as follows and effective on the pay period beginning December 22, 2024:

POLICE DEPARTMENT:

Add: Shift Differential: Swing Shift -3% additional, based on base policeman salary.

Add: Responsibility Differential: Two percent (2%) additional, based on base policeman salary for K9 Officer.
